LIMITED REVIEW REPORT

Review Report to
The Board of Directors,
PRABHAT SECURITIES LIMITED,

1. We have reviewed the accompanying statement of unaudited financial results of **M/s PRABHAT SECURITIES LIMITED**, (“the Company”) for the quarter ended 30th June, 2015 (“the Statement”), being submitted by the company pursuant to Clause 41 of the Listing Agreement with the Stock Exchanges, except for the disclosure in Part II – Select information referred to in paragraph 4 below. This statement is the responsibility of the Company’s Management and has to be approved by the Board of Directors. Our responsibility is to issue a report on these financial statements based on our review.
2. We conclude our review in accordance with the Standard on Review Engagement (SRE) 2410, Review of Interim Financial Information Performed by the Independent Auditor of the Entity’s issued by the Institute of Chartered Accountants of India. This standard requires that we plan and perform the review to obtain moderate assurance as to whether the financial statements are free from material misstatements. A review is limited primarily to inquiries of company personnel and analytical procedures applied to financial data and thus provide less assurance than an audit. We have not performed an audit and accordingly, we do not express an audit opinion.
3. Based on our review conducted as stated above, nothing has come to our attention that causes us to believe that the accompanying statement, prepared in accordance with the Accounting Standards notified under The Companies Act, 1956 (which continue to be applicable in respect of section 133 of Companies Act, 2013 in terms of General Circular 15/2013 dated 13th September, 2013 of the Ministry of Company Affairs) and other recognized accounting practices and policies has not disclosed the information required to be disclosed in terms of Clause 41 of the Listing Agreement with the stock Exchanges, including the manner in which it is to be disclosed, or that it contains any material misstatements.
